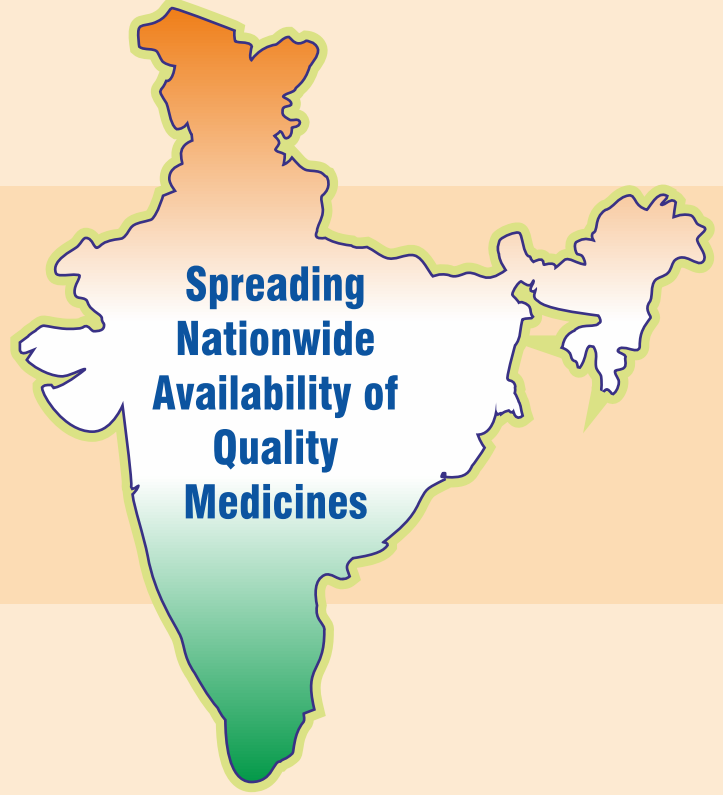

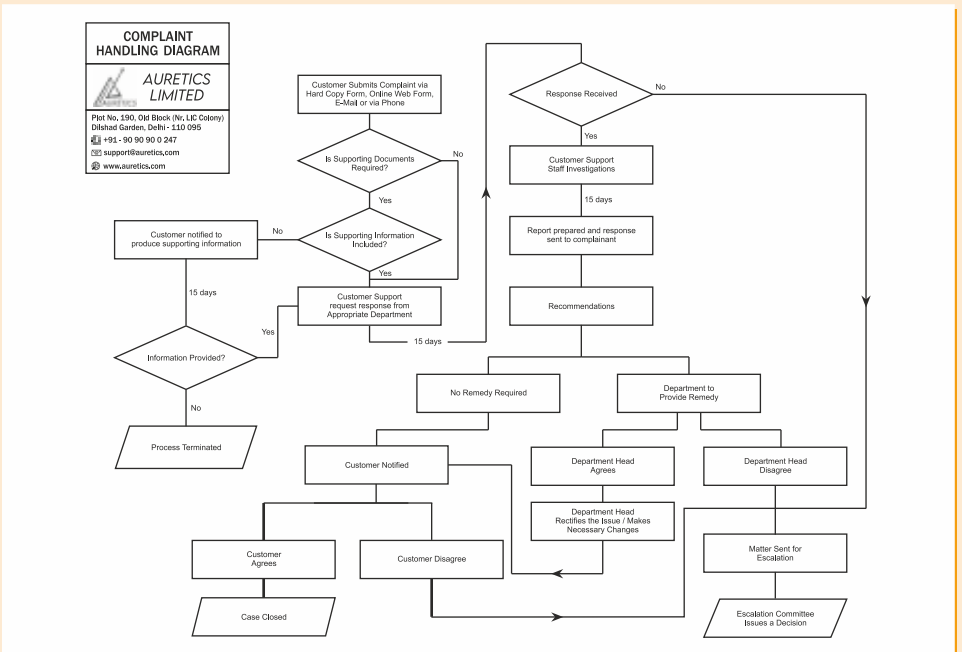

- DP** - Distributor's Price — Price offered to each individual distributor for direct purchase from the company.
- BV** - Business Volume — Each product is assigned a BV, which is a percentage of DP and all commissions are calculated from BV.
- PV** - Point Value — PV are calculated as a ratio of BV. The current PV:BV ratio is 1:10*. PV is used for title progression and income qualification.
*PV:BV ratios are subject to change.
- PBV** - Personal Business Volume — PBV is the sum total of BV bought by a person personally in any particular month.
- PPV** - Personal Point Value.
- TBV** - Team Business Volume — TBV is total BV from all the sponsors of an advisor and PBV from self-purchase in any particular month.
- TPV** - Team Point Value.
- GBV** - Group Business Volume — GBV is TBV which is allocated to infinity plain (i.e. after activation).
- GPV** - Group Point Value.
- SLBV** - Super Left Business Volume — Total Business volume generated by the first purchase (upto 1,000BV) done by your Left organisation before activation (i.e. allocated to Super Plan).
- SLPV** - Super Left Point Value.
- SRBV** - Super Right Business Volume — Total Business volume generated by the first purchase (upto 1,000BV) done by your Right organisation before activation. (i.e. allocated to Super Plan).
- SRPV** - Super Right Point Value.

- DC** - Distribution Center — DC are stock point of the company which is handled by company's independent distributors and are used to fulfil the needs of all advisors at local level.

Auretics Super Infinity Plan is a life changing opportunity for various individuals who have a feeling of entrepreneurship and are willing to work as an Independent Distributor. When you decide to enrol yourself as an Independent Distributor with Auretics, you are enduring a self-reliant and inspiring future for yourself.

This opportunity requires no pre-requisites in terms of education, occupation or experience. It requires no additional investment or renewal and comes with no target. Individuals can earn as per their own capabilities and devote time as per their choice.

The application of plan involves 4 simple steps (4 'S'), viz:

- ✓ **Self-use** Be a consistent user of products
- ✓ **Sell** Augment the business value by selling the products
- ✓ **Share** Earn more by sharing the products
- ✓ **Sponsor** Enrich yourself by supporting others

GENERAL INFORMATION ABOUT AURETICS COMPENSATION PLAN

Once you register yourself as an Independent Advisor with Auretics, you get two organisations. During registration, the new incoming advisor will get the option of getting a placement in either one of the organisation.

How Points are gained by the Advisor:

You will get points equivalent to matched PV of both the organisation. Eg. If your Organisation 1 has 1,000PV and your Organisation 2 has 2,000PV, then your matched PV will be 1,000PV.

Allocation of PV/BV earned with self-purchase:

Auretics Infinity Plan and Rocket Income provides further benefits to the advisor by automatically adding their self-purchases (after activation) to the organisation which has lesser number of PV at the month-end/day-end/7-day rolling end.

Please note, that Super Income does not have this benefit and only business from sponsors in the respective organisation will be considered.

Benefits to active Advisor:

Each bonus comes with its individual active criteria. You will get the benefit of that income only if you are active with the BV & PV as mentioned in the eligibility criteria of respective income.

Please note that in case you have not met the active criteria of the income then you will not receive any points for the matched BV & PV as the same will be deducted from the PV/BV earned and will be lapsed.

Carry Forward and Accumulation:

One of the biggest advantages of Auretics Super Infinity Plan is Lifetime Carry Forward and Accumulation of business done in both the organisation to active distributors. This means that any left-over business in both organisations will be carry forwarded to the next week/month.

Please note that carry forward is subject to minimum purchase every month. For Auretics Super Plan, Advisor will get the benefit of carry forward & accumulations of both organisation, only if he makes self-purchase of 300BV or more in the current month or previous month as on the day of weekly closing. For Auretics Infinity Plan, Advisor will get the benefit of Carry Forward & Accumulation of both the organisations, only if he makes self-purchase of 300BV or more in the current month.

Matching must be done either completely or after accumulation in the current month.

Matched BV / PV will not be carry forwarded or accumulated.

Please note, Auretics Rocket Income doesn't provide the benefit of carry forward and the complete business flushes-off at the day-end.

Allocation of PV of Super Plan to Infinity Plan:

Auretics provides you another advantage by adding the Super PV of both of your organisations to Infinity PV, thereby giving you a fast eligibility advantage.

Please note addition of Super PV in Infinity PV will increase your chance of getting eligible in infinity incomes but will not give any payout advantage of super business done by you.

Calculation of the same is done as under:

- 1) Last month's carry forwarded business is added to current month's business of the respective organisation.
- 2) Self-Purchases of the Advisor are added to the organisation with less PV.
- 3) Left Over (Unmatched) Business is Carry Forwarded.
- 4) Points are allocated based on the actual Business Volume done in Infinity Business.
- 5) Any Hardship Points are added to the Carry Forwarded business and Advantage points are deducted from the matching points.

A similar calculation is done, by taking Pure Infinity Business and calculation which gives more points (greater of the two) to the advisor is considered as final points of the advisor.

Closing and Payout:

Auretics Super Bonus is a weekly bonus where the week starts on Saturday and closes on Friday. Income is calculated after closure of the week and points are calculated on weekly basis. Payout of Super Income is released after 10 days from the date of closing of the week.

Auretics Infinity Plan is a monthly plan which starts from the first day of the calendar month and ends on the last day of the calendar month. Income is calculated after month-end and points of each income is calculated on monthly basis. Points varies from income to income and are calculated based on the size of the pool and number of individuals forming part of the same. Payout of Infinity plan is released after 10 days from the Last Day of the month.

Auretics Rocket Income is a daily income which closes daily and may stretches to 7 days to provide you additional benefit. The Payout of Auretics Rocket Income is disbursed along-with Super Bonus (i.e., after 10 days from the closure of the week).

Auretics Lifestyle Rewards are calculated on monthly basis and the rewards are announced after month end. Lifestyle rewards cannot be redeemed for cash and are given to the advisors during achievement functions.

Stability Fund:

The company may create a stability fund from the BV allocated to any income to stabilise its index value by transferring the amount from the pool when index value is high to stability fund which can then be used when the index value drops.

THE HIERARCHY SYSTEM

Each distributor is called Advisor. They will start as a **Blue Advisor**, and this will be a default level for new subscribers who have not ordered anything. Blue advisor needs to purchase goods of at least 100PV (1000BV*) to qualify for getting Bonus. After 1,000BV purchase, the advisor's title will become Advisor. The advisor hierarchy will increase as per the table mentioned:

SAVINGS ON SELF-CONSUMPTION

Auretics also has products for regular use & for all ages.

Auretics Advisors will get up to **25% margin** on the MRP & Buy one get one on most products on MRP which will ultimately lead to savings in household expenses. Further, they can also avail all the 11 types of Incomes/benefits offered by Auretics.*

Every product will have different retail margins and will be calculated as under:

$$\text{M.R.P.} = \text{D.P.} + \text{Margin on D.P. (\%age of D.P.)}$$

Eg. : If a product has Distributor's Price (DP) of Rs. 100 and margin on the same is 25%, then MRP of that product will be:

$$\text{D.P.} = ₹ 100$$

$$\text{Margin} = 25\% \text{ of } ₹ 100 = ₹ 25$$

$$\text{M.R.P.} = ₹ 100 + ₹ 25 = ₹ 125$$

These incomes will ultimately lead to savings in household expenses from the loyalty Re-Purchase products, retail margin and bonuses earned.

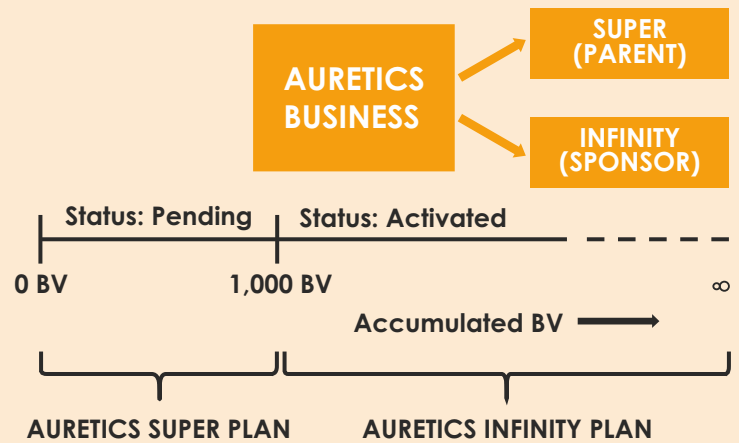


ABOUT AURETICS SUPER INFINITY COMPENSATION PLAN

Auretics Business inspires advisors to first build and then lead their team. Therefore, we have derived a hybrid plan [combination of Super with Infinity]. The Business Volume (BV) of every new distributor is allocated to Super Plan for first 100PV (1,000BV) worth purchases. Afterwards, their BVs will be allocated to Infinity Plan.

In order to become eligible for the Auretics Super Infinity Plan, each Advisor needs to activate themselves by purchasing any Auretics products worth 100PV (1,000BV) or more (Accumulated). This can be done in a single or in multiple orders.

Once the Advisor gets activated, they become eligible for compensation under both Super and Infinity Plan.



ABOUT AURETICS SUPER PLAN

Auretics Super Plan rewards you for developing your team. After sponsoring a new distributor, their first 100PV (1,000BV) purchases will be allocated to Super Plan. During registration, you will get an option to allocate your newly sponsored distributors under one of your organisation.

All incomes under Super Plan comes with no income level eligibility criteria. Therefore, you will be eligible for all the types of Incomes under the Super Plan as soon as you activate your distributorship. However, in order to become eligible for the pay-out, you will need to purchase Auretics Products of atleast 30PV (300PBV) in a month.

SUPER BONUS

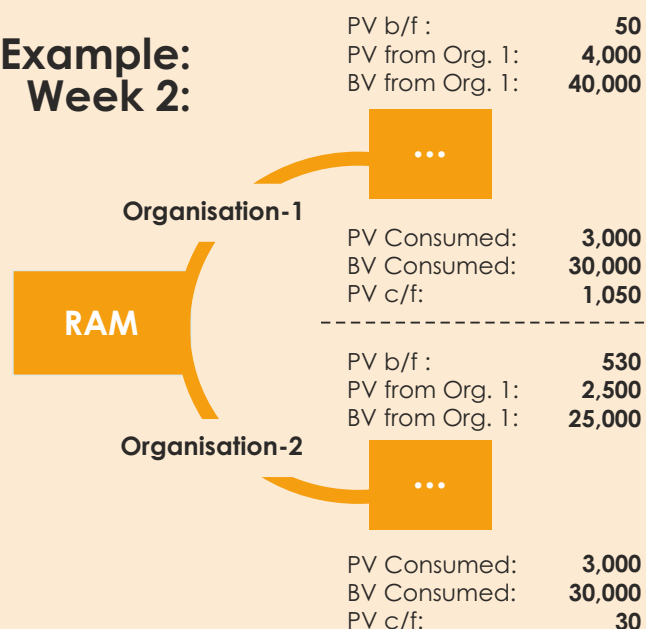

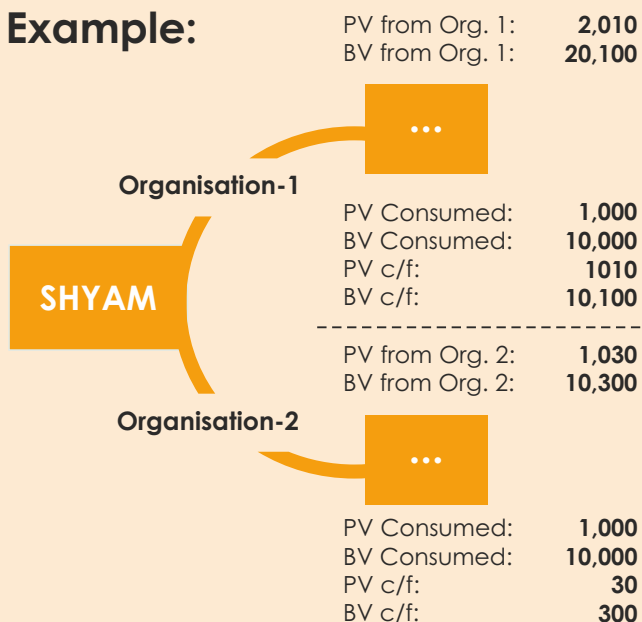

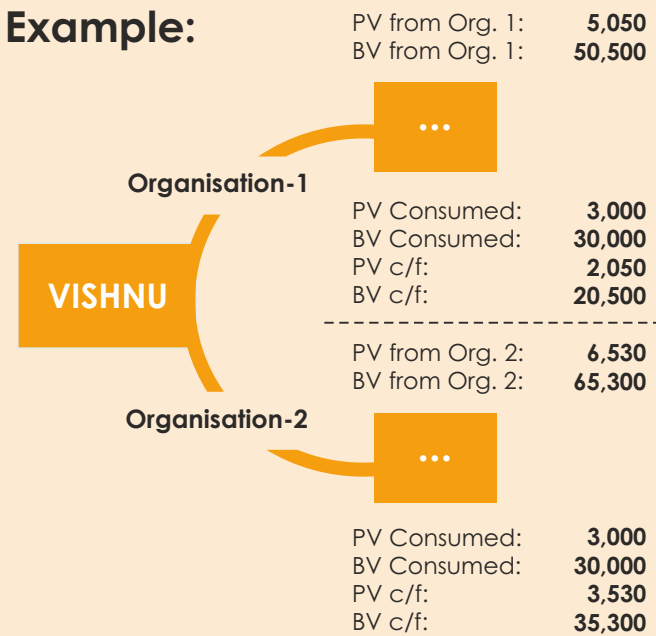

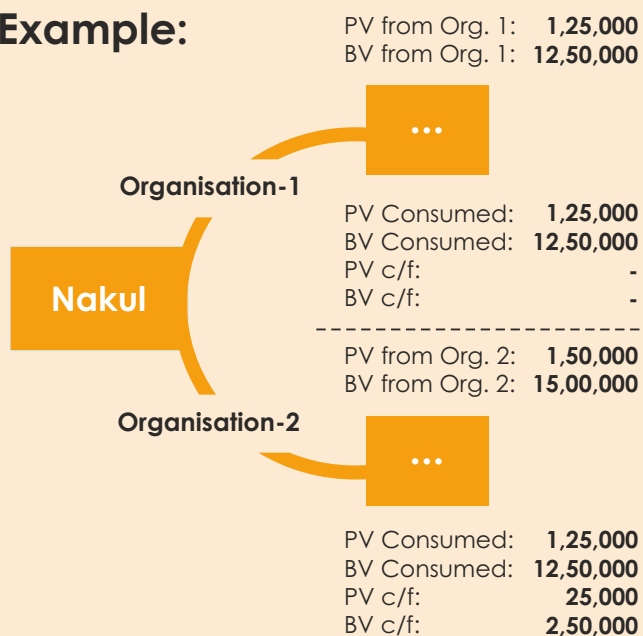
